#### PERSONAL INFORMATION COLLECTION STATEMENT 個人資料收集聲明

- 1. In accordance with the Personal Data Protection Act 2010 (PDPA), Vidyācaraṇa Buddhist Resource (VBR) will collect, record, hold, store, use, disclose and/or process personal information provided by an applicant through the completion of application procedures and forms designated for various purposes, such as for admission to a programme of study, for the issuance of student registration card, and for the provision of facilities or services. Data collected are used specifically for the purposes prescribed in the application forms and will serve as: 根據《2010 年個人數據保護法令》(PDPA), Vidyācaraṇa Buddhist Resource (VBR) 將收集、記錄、持有、存儲、使用、披露和/或處理申請人通過完成申請程序和指定表格提供的個人信息用於各種目的,例如入學、發放學生註冊卡以及提供任何設施或服務。 收集的數據專門用於申請表中規定的目的,並將用作:
  - a. the basis for selection of applications; a. 遴選申請的依據;
  - b. evidence for verification of the applicant's identity, examination results, academic records and other information; and 核實申請人身份、考試成績、學業成績等信息的證據; 和
  - c. where applicable, as part of the applicant's official student records.
    In the case of (c) above, information so incorporated into student records will be used for all purposes relating to the student's studies as required by the relevant regulations and procedures of the VBR. 如果適用,作為申請人正式學生記錄的一部分。

- 2. Personal data will be kept confidential and handled by the staff members of VBR. VBR may transfer some of the data to an agent or other persons appointed to undertake some of its academic and administrative functions. 個人資料將由VBR工作人員保密處理。VBR可能會將部分數據傳輸給代理人或指定承擔學術和行政職能的其他人員。
- 3. You have the right to request VBR to ascertain whether it holds your personal data, to be given a copy, and to apply for correction of the data, if deemed incorrect. 您有權要求VBR查明是否持有您的個人數據,並提供副本,如果認為數據不正確則申請更正。
- 4. Applications for access to and correction of personal data should be made in writing to the Programme Director of VBR and on payment of a fee. 提取和更正個人數據的申請應以書面形式向 VBR 項目總監提出,並支付費用。
